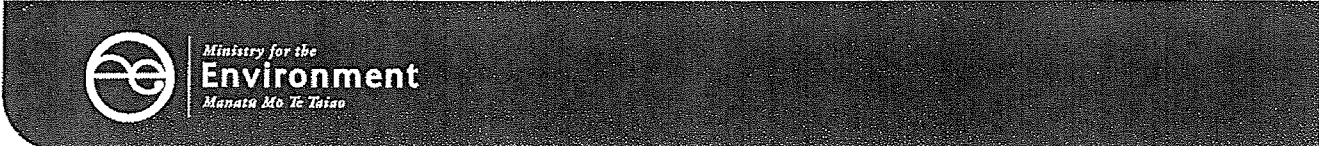

1/ Devaluation of Property -

Property in and around Raglan, particularly Mana + Whale Bay will be devaluated due to reduced aesthetic values. Residents have paid a premium to purchase property here.

2/ Loss of Enjoyment -

Loss of lifestyle + enjoyment for visitors + local residents due to diminished aesthetic values.

3/ Loss of Income -

Loss of income, present + future potential from business/properties dependent on natural environment - particular accommodation providers.

4/ Tourism -

The coastal landscape is Raglan's iconic landscape feature.

Raglan is voted by Lonely Planet as N.Z's most beautiful town. This undoubtedly includes the landscape. Tourism in Raglan provides income and lifestyle to local residents. This tourism is reliant on the pristine natural landscape of surf + surrounding views.

5/ Decommissioning Responsibility -

Alternative power technology is rapidly changing, wind farms have been proven to be 'not all that efficient'. When better technology is available in near future this Wind Farm could become redundant, leaving the liability of decommissioning the project.
