The reasons for my/our submission are:

Submission relates to transmission lines in the area of Lake Maraetai, Mangakino and the impact to the landscape amenity value of this land opposite Mangakino township. The existing landscape resource (pine plantation) contributes significantly to the character and heritage of the Mangakino area and therefore the protection of the landscape values is important. The proposed height of the overhead lines will be very visible from the Mangakino side of Lake Maraetai. It is therefore important to retain the the inherent natural quality and value of the undeveloped area. The visible impact of the transmission will be significant.

- 2 If the route is to be to the East of the Town (as proposed) that the alignment is such that the visual impact will be mitigated as much as possible (by using natural valleys etc) and/or that the height of the towers along this same is reduced by increasing the number of towers required.
