#### 1. Actions and decisions

#### 1.1. Litter (Increased Infringement Fee) Amendment Bill

This item seeks your approval for the Ministry to provide advisory services to the Environment Select Committee as it considers the Litter (Increased Infringement Fee) Amendment Bill. Hon Scott Simpson's Bill recommends increasing the maximum fine for a litter infringement offence from \$400 to \$1,000 (briefing note18-B-04530 refers).

Deborah Russell, Chairperson of the Environment Committee, sent a letter to Hon David Parker requesting the assistance of advisors from the Ministry for the Environment. We suggested to Minister Parker's office that the letter be referred to you for reply.

The work expected from the Ministry for a Members' BIII is similar to a Government BiII. If you agree to the request, at the end of June will we would provide the Committee with a first briefing. We may be asked to meet with the Committee, answer their questions, and attend oral hearings (which are likely to be in Wellington only).

We will keep you informed of the progress of the Bill and any significant changes to the amount of work involved.

#### 1. Updates for noting

#### 1.1. National Resource Recovery Project

The formation of the Ministry Task force for 'National Sword' is under way. The project is to be called the National Resource Recovery Project. Detailed project planning is now being carried out and procurement for consultancy staff to provide additional support to the Ministry is being fast-tracked. Once we have finalised the scope and budget, we will send you application for project funding under section 38 of the Waste Minimisation Act.

An independent economic analysis of the resource recovery sector is being procured and this will provide the platform for further feedback and advice to the Taskforce. A working group formed from industry experts as well as a local government advisory group will meet following the establishment of the Taskforce.

#### 3.2 Sustainable Coastlines

You have asked for information on the amount of funding for the Sustainable Coastlines WMF project 'A grass roots solution to litter in New Zealand'.

This project followed on from their previous successful WMF project which resulted in data on litter and litter interventions being collated and reviewed. A framework for future analysis was developed.

This new project is a nationwide, multifaceted project and therefore requires a large investment. The Ministry is confident that Sustainable Coastlines are able to complete a project of this size.

The two main objectives of Sustainable Coastline's three year project are to understand the problem of litter and optimise solutions. This work will Include:

- · designing and building an open-sourced national litter database
- training and supporting citizen scientists to gather beach litter data throughout New Zealand
- designing and building litter education for a curriculum; and
- training and supporting educators to deliver education

The project, worth a total of \$2.8 million (WMF is contributing just under \$2.7 million), can be roughly divided into thirds in terms of the allocation of funds—1/3 for the creation of the litter database, 1/3 for the education component, and 1/3 for the roll out and training of Citizen scientists.

The Sustainable Coastlines project is part of a suite of projects aimed at making progress in better managing litter in New Zealand. The other projects are run by Keep New Zealand Beautiful, The Packaging Forum and Marlborough District Council. Combined, the projects are intended to support a shift in littering behaviours by our communities, inform decisions on where to place litter services and provide good evidence for any changes that we may need for litter policy.
