Example: The public sector Ministries must all have policies requiring non fossil fuel heating of all new schools, hospitals etc-use established clean options instead such as wood chip boilers or heat pumps. Power companies such as Meridian need to be bought into line to support solar photo-voltaics (remove threat of solar tax). Compensate for air-conditioning cooling in Schools by adding solar PV on a capital free lease option (Ministry of Education policy) etc.
