Even if we all have electric cars by 2050, that is still a lot of electricity coming from somewhere, so making public transport that really supports people to get out of their cars and into trains and buses. Public transport needs to be affordable, at present those living in poorer areas often have significant fares to get anywhere on public transport which makes it untenable. Obviously government needs to work with farmers to reduce carbon dioxide and methane output by farm animals. We must change the amount of meat and dairy we promote and consume as a country, it's not sustainable in any way. A big change of mindset around how and what we consume and how and what we farm is needed.
