Clause

1. What process should the Government use to set a new emissions reduction target in legislation?

Position

The Government sets a goal to reach net zero emissions by the second half of the century and the Climate Change Commission advises on the specific target for the Government to set later

Notes

There needs to be more detailed information and research on how the target is to be achieved and mitigation of effects on different regions of the country.

2. If the Government sets a 2050 target now, which is the best target for New Zealand?

Position

Net Zero Long-Lived Gases and Stabilised Short-Lived Gases - Long-lived gases to net zero by 2050 while also stabilising short-lived gases

Notes

Net zero shorter lived gases such as methane are probably not going to be able to be got to net zero in the timeframe suggested.

3. How should New Zealand meet its targets?

Position

Domestic emissions reductions only (including from new forest planting)

Where possible from our own resources, but I would not be averse to using overseas reductions for a defined short term, however they are likely to become more costly if wealthy economies compete for them.
