I agree with the phase out of single use plastic bags (as soon as possible please). From my research, I can't agree compostable bags that meet standards (international available currently) and made of oil based material and starch-based material, can be included in the same category as degradable and biodegradable. Yes I agree they are single-use and need to be phased out, and meanwhile directed at end of use, into a commercial compost facility, and we need to ensure they meet standards and compost with no toxic residue. But we need to provide infrastructure for other compostable take-away food and supermarket packaging anyway. These bags are a better alternative I believe than 'multi-use' thicker-plastic bags which I've heard are being touted as a solution by some large retailers in Australasia. Thicker plastic doesn't blow as easily yet it breaks down the same and doesn't go away. still entering our food chain and suffocating/starving marine life.

Multi-pronged approach. Incentives and promotion / education. Reusable bags by definition need to be almost infinitely reusable and repairable. Thicker plastic and polypropylene bags for example are technically multi-use, but their re-usable life is limited and they are toxic after disposal. A scheme to promote bags, recycled, specially made to last esp. from natural fibres that can be in a circular boomerang style scheme has to be worth considering to avoid bad alternatives and replacements from proliferating from retailers care of the plastics industry.
